

MOON LAKE PUBLISHING CONTEST RULES, TERMS AND CONDITIONS

THIS CONTEST IS ONLY OPEN TO CANADIAN AND AMERICAN RESIDENTS AND IS GOVERNED BY CANADIAN LAW AND THE LAWS OF THE PROVINCE OF ONTARIO.

NO PURCHASE NECESSARY. SEE BELOW FOR FULL CONTEST DETAILS. PARTICIPATION IN THIS CONTEST CONSTITUTES YOUR FULL AND UNCONDITIONAL ACCEPTANCE OF, AND AGREEMENT TO BE LEGALLY BOUND BY, THESE CONTEST RULES (THE “CONTEST RULES”).

1. Contest Period

The Contest ends on February 15, 2019 at 12:00 a.m. Eastern Time (“ET”). The Contest is open to all residents of Canada and the United States of America who have reached the age of majority in their state, province or territory of residence at the time of entry.

2. How to Enter

NO PURCHASE NECESSARY. To participate in this Contest you must follow these submission guidelines.

(a) Each submission must result in a story that is no longer than five pages.

(b) Writing a Script:

the script must result in a comic that would be completed in 5 pages or less. This means you may have a 10 page PDF for writing the script, with 5 pages worth of a comic story in said PDF.

(c) Creating a Completed Comic (with Illustration):

The final file must result in a comic that is five pages or less. Please ensure that you maintain any raw files or scans for editing purposes if you’re chosen as the winner, as well as the final image files.

3. Compensation

(a) Compensation will be remitted by Unkatush Inc. c/o Moon Lake by Dan Fogler

(b) Unkatush Inc. acknowledges that the Artist’s page rate (“Page Rate”) is \$100

CAD per Finished Page (Story, Pencils, Inks and Colouring), to a Maximum of five (5) pages. Submissions in the 'Writing a Script' category will be paid \$20 per page up to 5 pages

- (c) Amounts are payable 60 days after the announcement of the Grand Prize Winner , upon completion of a signed written agreement between the winner and Unkatush Inc.

4. Credit

Subject to the successful completion of the interior artwork according to the terms and conditions of this Agreement:

- (a) Artist shall be credited as "INSERT NAME" in all credits of the Comic Series.
- (b) Artist shall be entitled to an appropriate credit for interior artwork to be displayed in the credits of the issues of the Comic Series.
